Riding Information:

Note the 2008 Tetrathlon Rule Changes:

- **Elimination & Mandatory Retirement** in riding at the third refusal on course
- **Elimination & Mandatory Retirement (may not remount)** on first fall of rider or horse anywhere on the site on the day.

To qualify for optimum points you must jump your division's standard height:

Senior: 3'3" Junior: 2'9" Novice A: 2' Novice B: 18" Tadpole: Poles

Riders not comfortable at these heights may jump any height lower than the standard, with penalty. Please tick which height you plan to jump in the stadium competition:

- 3'3" - **Seniors** only (no penalty).
- 2'9" - **Juniors** (no penalty). Seniors with a 250 point penalty.
- 2'3" - Juniors & Seniors with a 250 point penalty.
- 2' - **Novice A** (no penalty). Juniors & Seniors with a 250 point penalty.
- 18" - **Novice B** (no penalty). Nov A, Juniors & Seniors with a 250 point penalty.
- Ground Poles - **Tadpoles** (no penalty). Everyone else with a 250 point penalty.
- Lead over Poles - Anyone, with a 250 point penalty.

Long-sleeved shirts (no show jacket required), certified helmet, heeled boots and medical armband are mandatory. Salute the judge.

Important Note: On the day, the Event Warm-up Coach has the discretion to downgrade any rider who is deemed unsafe at their chosen height. The Warm-up Coach's decision is final.

Shooting Information:

Shooting Standards:

- Senior & Junior, 10m, one hand only
- Novice A and Novice B, 10 m, two hands, no resting
- Tadpoles, 10m, two hands, resting allowed

Seniors & Juniors using two hands, or Novices resting their arms or guns on the table whilst firing may be **eliminated** from the shooting phase, and receive 0 points in the shoot. This is worse than shooting with the correct number of hands yet not hitting the target at all, as you get 175 points for trying.

Tadpoles **must** and Novices **should** have an assistant at the line to help pump/load the pistol.

Seniors & Juniors: 2000m

Novice A: 1000m

Novice B & Tadpole: 500m

There will be a course walk before the run. Please pay attention, so that you do not get lost when you are running on the course by yourself. Runners will start individually, at 15 sec or 30 sec intervals (depending on the number of runners).
